### LOCOMOTIVE HAULED COACHING STOCK

#### PLATED NUMBERS

Commencing with this Amendment Sheet, carriages registered for operation on the Railtrack network but not registered with a 99xxx number will be shown as 'Railtrack Registered'. For example FO 3130 that has recently been registered for mainline use as number WDS99128 will be shown 'WDS99128' whilst TSO 5171 that has recently been registered for mainline use as number 5171 will be shown 'Railtrack Registered'. ## 5) News of Mainline Operators

a) Carriage & Traction Company Ltd

The re-registration of BCK 21245, recorded above, has resulted in all carriages owned by this company now carrying either capital stock or service stock numbers. Not previously recorded here, but widely reported elsewhere, is that the carriages in the mainline fleet are managed by Rail Charter Services Ltd. Actual ownership remains with the Carriage & Traction Company Ltd until such time as all the surplus vehicles have been disposed of. Thus, in future information on the mainline carriages will be shown under the heading 'Rail Charter Services Ltd' (see below). Details of the non-main line coaching stock will continue to be given under this heading.

The current Carriage & Traction Company Ltd. stored fleet is shown below along with details of the current storage locations. All vehicles are Air-braked only except those shown v which have Vacuum-brakes only or x which are Dual-braked.

The fleet of carriages currently operated is shown below. All carriages are now allocated to Bounds Green T&RSM and formed into four sets each of which has a distinctive livery. These are set BN91 in Carmine and Cream livery, BN93 in VIP livery, BN94 in Blue and Grey livery, although some carriages still retain InterCity livery, and BN96 in Southern Green livery. At the time of writing four of the carriages had not seen use during 1999, these are RBs 1667 & 1674 and TSOs 4959 & 4977. All vehicles are Air-braked only except those shown x which are Dual-braked

c) Wessex Trains Ltd

It will be noted from entries in the 'detail alterations' section that several carriages have now been fitted with air-brake equipment, they have thus become dual (air/vacuum) braked. Dual braked carriages now in the fleet are RB 1659, RMB 1861, TSOs 4905, 4940, 4951, 4960, 4973, 4994, BSK 35317 and Courier Vehicle 80220. The two outstanding TSOs, 4910 and 4984 are still located at the Watercress Line and have yet to be moved to Carnforth to have air-brake equipment fitted. No reports regarding progress with FO 3065 have been received and it is understood that no further repaints into Pullman Car livery have yet taken place.

**9) Corrections to 'Amendment Sheet Number 30'**
